**Subject : Grant of Ex-gratia payment to widows of deceased  
Contributory Provident Fund Retirees.**

The undersigned is directed to invite attention towards Finance Department Memorandum of even number dated 01.06.1998 vide which Ex-gratia payment to alive widows of Jodhpur Contributory Provident Fund Retirees / beneficiaries, who died while in service, was allowed at the rate of Rs.572/- per month plus Dearness Relief sanctioned from time to time.

Consequent upon revision of pay scales of the State Government employees, the pension of the State Pensioners / Family Pensioners has been consolidated and they are being allowed payment of Dearness Relief at the revised rates on consolidated pension.

Accordingly, the Governor is pleased to order that the Ex-gratia payment admissible to the aforesaid widows may be revised to Rs.1293/- p.m. plus Dearness Relief as may be sanctioned from time to time to the State Pensioners.

This order shall be deemed to have come into force with effect from 01.01.2007.
