Sub: Grant of Family Pension to the family of a deceased pensioner, who was sanctioned pension by the State Government on his absorption in Public Sector Undertaking of Government of India.

In accordance with the provisions contained in the Section V of Appendix IX of Rajasthan Civil Services (Pension) Rules, 1996, in the case of absorption of State Government Employees in the Public Sector Undertakings under the control of the Government of India, they are not entitled to family pension under Chapter V and XII of Rajasthan Civil Services (Pension) Rules, 1996.

In such cases, Government of India has already allowed family pension.

Accordingly, the matter has been considered and the Governor is pleased to order that in cases where pension is admissible to the pensioners, who have been finally absorbed in Public Sector Undertakings of Government of India, under FD Memorandum No. F.12(3)FD/Rules/2008 dated 22-4-2010, family pension may also be allowed to the family of such pensioners after their death.
