**Sub: Revision of Pension of pre-01.09.2006 State Pensioners /
Family Pensioners etc.**

Attention is invited towards the provisions contained in para 8 of Finance Department Memorandum of even number dated 12-09-2008 under which Pensioner / Family pensioner on attaining the age of 80 years or above has been allowed additional quantum of pension / family pension from the actual date on which they attain the age of 80 years or above.

The matter has been considered and the Governor is pleased to order that the Pensioner / Family pensioner including Pensioner / Family Pensioner of Rajasthan Judicial Service and Rajasthan Higher Judicial Service, who are entitled for additional pension / family pension under Finance Department order No. F.12(4)FD/Rules/2010 dated 27-08-2010 may be allowed the additional quantum of pension / family pension on attaining the age of 80 years and above, from the 1st day of the month in which his / her date of birth falls. For example, if a Pensioner / Family Pensioner completes age of 80 years on any date in the month of August, 2008, he will be entitled to additional pension / family pension w.e.f. 01-08-2008. Those Pensioners / Family Pensioners whose date of birth is 1st August, will also be entitled to additional pension / family pension w.e.f. 1-8-2008 on attaining the age of 80 years and above.

The cases decided earlier may also be reviewed and revised in accordance with the provisions of this order.
