**ORDER**

**Sub: Non-accrual of arrear of pensionary benefits.**

Attention is invited towards Finance Department Notification No.F.12(3)FD/Rules/2008 dated 12.09.2008 under which provision has been made regarding non-accrual of arrears of pensionary benefits for the period of notional revision of pay scale of State Government employees for the period from 01.09.2006 to 31.12.2006. The State Government has also revised the pay scales of Government Polytechnic College Teachers / Librarians / PTIs with effect from 01.09.2006 vide Notification No.F.9(3)FD/Rules/2010 dated 01.09.2010 with the condition that no arrear of pay and allowances would accrue to them for the period from 01.09.2006 to 31.12.2008.

Accordingly, the Governor is pleased to order that on the same lines in respect of Government Polytechnic College Teacher / Librarians / PTIs retired / died while in service during the period 01.09.2006 to 31.12.2008, no arrear of pension shall accrue to them upto 31.12.2008. Pension / Family Pension calculated on pre-revised pay shall only be payable upto 31.12.2008 and the pension / family pension on revised notional pay shall be payable with effect from 01.01.2009. The Commutation and Gratuity to these Government Polytechnic College Teachers / Librarians / PTIs shall not be admissible on the revised notional pay and the amount of Commutation and Gratuity already paid / payable on the pre-revised pay shall be treated as final.
