NOTIFICATION

Sub. :- Amendment in the Rajasthan Civil Services (Pension) Rules, 1996.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996 namely :-

1. These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2014.
2. These rules shall come into force with immediate effect.
3. In the aforesaid rules -

(i) Below existing Rule 151, the following 'Government of Rajasthan's Decision' shall be inserted, namely :-

"Government of Rajasthan's Decision

In the following cases re-employment shall be made after prior approval of Department of Personnel and Finance Department :-

1. *Re-employment of retired officers and employees in regulatory Commission / Administrative and other Tribunals etc.*
2. *Re-employment of retired officers and employees as senior personal staff of the Ministers coterminus to the tenure of Ministers.*
3. *Re-employment of ex-servicemen as Secretary, District Soldiers Board or other who held post not below the rank of Commissioned officers in the Defence Forces.*
4. *Re-employment of retired Judge, as Judge District, Consumer Forum or in other semi judicial / judicial forums.*
5. *Re-employment of retired officers in the Enquiry Commission coterminus with the period of Commission.*
6. *Re-employment of retired persons as Chairman and Member of the Commission constituted under Law.*
7. *Re-employment of retired officers with exceptional abilities and skills needed for specific assignments.*
8. *Employment of retired persons of more than 65 years of age in exceptional cases.*

(ii) The existing clause (b) of Rule 152 shall be substituted by the following :-

- (b) *Pay on re-employment of a pensioner shall be fixed on the basis of pay last drawn (sum of pay in running pay band and grade pay) by him at the time of retirement minus the pension.*

- (ii) The existing clause (d) of Rule 152 shall be deleted.
- (iv) The existing Rule 153 shall be deleted.
- (v) The existing Rule 155 shall be deleted.
- (vi) The existing Rule 156 shall be substituted by the following, namely :-

156 (1) The drawal of DA, other allowances and facilities, if allowed shall be admissible on the net pay fixed under Rule 152 on re-employment under Rule 151.

(2) Following allowances and facilities in appropriate cases shall be allowed to persons re-employed under Rule 151 after specific approval of Finance Department on case to case basis :-

1. *House Rent Allowance*
2. *Telephone Facility - 50% of facility allowed to officers of equivalent rank*
3. *Transport Facility*
4. *Medical Facility - only in cases where Medical facility to retired employee is not available under Rajasthan Pensioners Medical Scheme / under CGHS*

Government of Rajasthan's Decision

Following allowance and facility shall not be admissible during the period of re-employment :-

1. *City Compensatory Allowance*
2. *Facility of News paper and Magazine"*

- (vii) The existing Rule 158 shall be substituted by the following, namely :-

"Rule 158 - Leave and leave salary

In the case of persons re-employed after retirement, the provisions contained in the Rajasthan Service Rules regarding leave and leave salary shall apply except the following :-

1. *Encashment of balance of PL during the period of re-employment*
2. *Encashment of balance of PL on expiry of re-employment*
3. *Medical Leave"*
