**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:

**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Civil Services (Pension) (First Amendment) Rules, 2015.  
(2) They shall come into force with immediate effect.

**2. Amendment of rule 134.-** In sub-rule (1) of rule 134 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules,-

- (i) in clause (viii), for the existing expression “; or” ,appearing at the end, the expression “;” shall be substituted.
- (ii) in clause (ix), for the existing punctuation mark “.” ,appearing at the end, the expression “; or” shall be substituted.
- (iii) after the existing clause (ix), so amended, the following new clause (x) shall be added, namely:-


“(x) Life Certificate issued online by a Government Agency as a result of Aadhaar Biometric Authentication shall also be accepted as a valid certificate.”

**3. Amendment of rule 136.-** After the existing sub-rule (3) of rule 136 of the said rules, the following new sub-rule (4) and (5) shall be added, namely:-

“(4) A Life Certificate issued online by a Government Agency as a result of Aadhaar Biometric Authentication shall also be accepted as a valid certificate. Life Certificate may be accessed by the Pension Disbursing Agency through the website notified by the State Government without insisting personal appearance of the pensioner or Life Certificate by the competent authority referred above.

(5) The process for getting digital Life Certificate by the pensioner shall be such as may be notified by the State Government.”


