ORDER

Sub: Calculation of Gratuity and Cash payment in lieu of unutilized privilege leave in respect of State Government employees retired during the period from January, 2020 to June, 2021.

Ref: Finance (Rules) Department order of even number dated 11-03-2022.

Vide this Department's order of even number dated 11-03-2022, it had been decided that in respect of State Government employees who retired on or after 01-01-2020 and upto 30-06-2021, the amount of DA to be taken into account for calculation of gratuity and cash payment in lieu of unutilized privilege leave will be deemed to be as under :

Employees retired during the period	Notional Percentage of Dearness Allowance (DA) for calculation purpose
From 01-01-2020 to 30-06-2020	21%of basic pay
From 01-07-2020 to 31-12-2020	24%of basic pay
From 01-01-2021 to 30-06-2021	28%of basic pay

In this order dated 11-3-2022 it was mentioned that separate order will be issued for the retired employees who were appointed on or after 1-1-2004 and governed by Rajasthan Civil Services (Contributory Pension) Rules, 2005.

For the retired employees who were appointed on or after 1-1-2004 and governed by Rajasthan Civil Services (Contributory Pension) Rules, 2005, the notification dated 19-5-2022 regarding repealing of Rajasthan Civil Services (Contributory Pension) Rules, 2005 was issued and also amendment in RCS (Pension) Rules, 1996 was issued vide notification dated 19-5-2022.

Accordingly, it has been decided that the order dated 11-3-2022 shall also be made applicable for the employees who were recruited on or after 1-1-2004 and retired between 01-01-2020 and 30-06-2021.
