**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Service Rules, 1951, namely :-


**1. Short title and commencement.-** (1) These rules may be called the Rajasthan Service (First Amendment) Rules, 2016,  
(2) They shall come into force with immediate effect.

**2. Amendment of rule 160.-** The existing sub-rule (4) of rule 160 of the Rajasthan Service Rules, 1951, shall be substituted by the following sub-rule (4) and sub-rule (4A), namely:-

"(4) On an application of a Government Servant, photo copy of service book, duly attested by the officer or authority competent to make entries in the service book, shall be supplied to him on payment of rupees two per page of any size.

(4A) The original service book maintained in the department shall only be authentic document but in the event of non-availability of original service book assistance for the purpose of pay fixation and finalisation of pension case may be taken from the photo copy of service book in the possession of Government Servant provided that entries in the photo copy of service book are attested under the signature of officer or authority specified in sub-rule (4). In cases, where pay fixation and pension cases are finalised on the basis of entries in the photo copy of service book, an undertaking to this effect shall invariably be obtained from the Government Servant, that he agrees to refund any over payment of pay, allowances and pension etc. which are found to have been made as a result of fixation of pay or pension or both on the basis of entries of duly attested photo copy of service book."


