**Subject :- Deputation of a Government Servant under Rule 144A
of Rajasthan Service Rules 1951.**


The term and conditions of the state Government servants transferred on deputation/foreign service to Central Government, other State Governments, Public undertaking, autonomous bodies are regulated as prescribed in Rule 144A of Rajasthan Service Rules 1951.

A question has been raised whether Government servant transfer/deputed to Boards, Corporations, Autonomous Institutions etc. which have been established under the control of their Administrative Department or Appointing Authority is deputation under Rule 144A of Rajasthan Service Rules 1951 or not.

The matter has been considered and it has been decided that such posting of Government servants to Corporations, Boards Autonomous Institutions etc. which are established under the control of their Administrative Department or Appointing Authority shall not be termed as Deputation. Hence the provision of Government of Rajasthan decision appearing below rule 144A of Rajasthan Service Rules as amended from time to time including deputation allowance shall not be applicable on these employees.

The provisions of this order shall also be applicable to the Government servants who are already on deputation on the date of issue of this order.
