
Subject : Guidelines regarding foreign travel by Ministers and Officials of State Government and PSUs and the Autonomous Bodies of the Government of Rajasthan.

Guidelines regarding foreign travel by Ministers and Officials of State Government and PSUs and the Autonomous Bodies of the Government of Rajasthan are contained in Finance Department Circular No. F.6(8)FD/Rules/2005 dated 13.10.2006.

Department of Economic Affairs, Ministry of Finance, Government of India vide guidelines dated 18.09.2019 has directed that proposal regarding foreign visit of Ministers / Members of legislative assemblies / Officials of State / UT Govts often do not contain the complete details (i.e. Political Clearance / FCRA Clearance etc.) and are not submitted well in time. Therefore Department of Economic Affairs, Ministry of Finance, Government of India has required that proposals for foreign visit should be submitted to the Department of Economic Affairs complete in all respects, and at least three (3) weeks in advance, so that this Department would have sufficient time to clear the proposals.

The compliance of above mentioned instructions may please be ensured.
